**Information provided to applicants pursuant to Section 54 (2) no. 8 in conjunction with Section 53 of the Residence Act, and Section 53 (2) in conjunction with Section 41 (1) no. 2 of the Federal Central Criminal Register Act**

A foreigner can be expelled if he or she has furnished false or incomplete information in order to gain a German residence permit or a Schengen visa.

The applicant is obliged to provide all information to the best of his or her knowledge and belief. If he or she refuses to provide data or knowingly furnishes false or incomplete information, the visa application may be refused or, if a visa has already been issued, the applicant may be expelled from Germany.

Under Section 53 (2) in conjunction with Section 41 (1) no. 2 of the Federal Central Criminal Register Act, the Authority has an unlimited right to demand information on non-deletable convictions recorded in the Federal Central Criminal Register, even if these are no longer included on a certificate of conduct. Therefore the applicant is obliged also to disclose criminal convictions that are not included on a certificate of conduct.

**تعليمات بموجب المادة ٥٤ الفقرة ٢ البند ٨ والمادة ٥٣ من قانون الإقامة الألماني والمادة ٥٣ الفقرة ٢ والمادة ٤١ الفقرة ١ البند ٢ من قانون الاتحادي للسجلات الجنائية**

يمكن إبعاد أي أجنبي من ألمانيا إذا قام بالإدلاء ببيانات خاطئة أو غير كاملة بهدف الحصول على تصريح إقامة ألمانية أو الحصول على تأشيرة شنجن.

مقدم الطلب ملزم بالإدلاء بكافة البيانات بكل دقة وصدق. وعند رفضه الإدلاء ببيانات أو الإدلاء عمداً ببيانات خاطئة أو غير كاملة فمن الممكن أن يؤدي ذلك إلى رفض طلب منح التأشيرة أو إلى إبعاد مقدم الطلب من ألمانيا حال حصوله التأشيرة سلفاً.

وفقاً للمادة ٥٣ الفقرة ٢ والمادة ٤١ الفقرة ١ البند ٢ من القانون الاتحادي للسجلات الجنائية فإن للسلطات الألمانية حق غير محدود في الاستعلام من السجل الاتحادي الجنائي عن الأحكام المسجلة به والتي لا يمكن شطبها منه، وذلك حتى لو لم تعد تلك الأحكام تذكر في صحيفة الحالة الجنائية. وعليه فإن مقدم الطلب يكون ملزماً بالإدلاء بالأحكام الجنائية التي لم تعد تذكر في صحيفة الحالة الجنائية.

يؤكد مقدم الطلب بموجب توقيعه بأنه أحيط علماً - قبل تقديم طلب التأشيرة الخاص به - بالتبعات القانونية المترتبة على الإدلاء ببيانات خاطئة أو غير كاملة في إطار إجراءات التأشيرة.
